Our Commitment to You

Mission Park Capital, LLC (“Mission Park”) is committed to safeguarding the use of your personal information that we have as your Investment Advisor. Mission Park (referred to as "we", "our" and "us" throughout this notice) protects the security and confidentiality of the personal information we have and make efforts to ensure that such information is used for proper business purposes in connection with the management or servicing of your account. Our relationship with you is our most important asset. We understand that you have entrusted us with your private information, and we do everything we can to maintain that trust.

We do not sell your non-public personal information to anyone. Nor does Mission Park provide such information to others except for discrete and proper business purposes in connection with the servicing and management of your account as discussed below.

Details of our approach to privacy and how your personal non-public information is collected and used are set forth in this privacy policy.

The Information We Collect About You

You typically provide personal information when you complete the paperwork required to become our Client. This information may include your:

- Name and mailing address
- E-mail address
- Phone number
- Social security or taxpayer identification number
- Birthdate
- Assets
- Income
- Account balance
- Investment activity
- Accounts at other institutions

In addition, we may collect non-public information about you from the following sources:

- Information we receive on Brokerage Agreements, Managed Account Agreements and other Subscription and Account Opening Documents;
- Information we receive in the course of establishing a customer relationship including, but not limited to, applications, forms, and questionnaires;
- Information about your transactions with us or others

Information about You That Mission Park Shares

Mission Park works to provide products and services that benefit our customers. We can only share non-public personal information with non-affiliated third parties (such as, but not limited to, brokers and custodians) as necessary for us to provide agreed services and products to you consistent with applicable law, and only after receiving specific consent from you to share that information, which is provided here and in the investment advisory agreement. This includes, but is not limited to, generative artificial intelligence (“AI”)-powered agents, such as the Hazel service (the “Assistant”) offered by Altruist Corporation intended for investment advisors, and other related AI services for the purpose of providing products and services that benefit our customers.

By accepting this privacy policy, you agree to Mission Park's use of the Assistant and other related AI services, and further acknowledge that in using the Assistant, this data will be shared with third-party vendors, including but not limited to LLM Providers. By accepting this privacy policy, you are providing affirmative prior consent and agree in advance to participate in meetings where the Assistant will record a meeting.

No personally identifiable information ("PII") or Client-specific data will be used to train AI models or LLM Providers, no PII be retained by the AI models or LLM Providers, and no PII will leave the United States of America. In addition, Mission Park will always evaluate the results of any artificial intelligence use and will not unilaterally accept the output from artificial intelligence platforms.

Your non-public personal information may also be disclosed to you, persons we believe to be your authorized agent or representative, or regulators in order to satisfy Mission Park's regulatory obligations, and as otherwise required or permitted by law.

To repeat, we do not sell your non-public personal information to anyone, and will not share your non-public personal information with non-affiliated third parties without your consent.

Information about Former Clients

Mission Park does not disclose, and does not intend to disclose, non-public personal information to non-affiliated third parties with respect to persons who are no longer our clients.

Confidentiality and Security

Our employees are advised about the firm's need to respect the confidentiality of our customers' non-public personal information. Additionally, we maintain physical, procedural and electronic safeguards in an effort to protect the information from access by unauthorized parties.

SMS Disclosure

By providing your phone number, you are opting-in to receive updates, offers, and news via text message from Mission Park and we may share your data with trusted service providers who assist us in operating our SMS program, provided they agree to keep your data confidential and use it solely for the purpose of providing services on our behalf. Messages will be recurring and frequency may vary. Message and data rates may apply. Reply STOP at any time to unsubscribe.

Opt-Out Options For Marketing Communications and Mobile Information

You have the right to opt out of receiving marketing communications from us at any time by:

- SMS: Replying "STOP" to any SMS message you receive from us.
- Email: Replying "STOP" to any email you receive from us.
- Our SMS program provides updates, offers, news, notifications, and promotional messages related to our services. By subscribing to our SMS program, you consent to receive SMS messages at the phone number provided. Message frequency may vary based on your interaction with our service.
- We do not share your mobile information with third parties or affiliates for marketing or promotional purposes. Additionally, all the categories of personal data mentioned above exclude text messaging originator opt-in data and consent. This information will not be shared with any third parties under any circumstances. However, we may share your data with trusted service providers who assist us in operating our SMS program, provided they

agree to keep your data confidential and use it solely for the purpose of providing services on our behalf.
